- Dr. Lewis advised the board that the men's basketball program has been placed on a one year probation by the MACJC. A recruit from McComb, Mississippi, had an article about his recruiting visit to Pearl River Community College written about him in his local newspaper. The article contained a picture of the player in a Pearl River basketball jersey prior to the published NJCAA signing date which is a violation of NJCAA and MACJC rules. Even though the Pearl River coaches had no knowledge of the picture being taken, the MACJC determined that the program was still responsible.
- Announced that the Hancock County Board of Supervisors has reappointed Frank Ladner to another five-year term on the PRCC Board of Trustees. His new term is effective January 1, 2017 to December 31, 2021.
