### **Buildings and Grounds Committee**

Dr. Breerwood presented the Pearl River Community College Aviation and Aerospace Training Hangar Project Bid Tabulation document to the Board of Trustees.

A motion was made by the Buildings and Grounds Committee to accept the bid of Samuel B. Day for a price of \$2,475,000.00 as stated and defined herein. The motion was unanimous.

#### **Financial Reports**

Ms. Clark presented and reviewed the **Reconciled Bank Balances ending September 30, 2021,** and Unrestricted Current Fund Statement of Expenditures ending September 30, 2021. No board action was necessary for these reports.

Ms. Clark presented for review and approval the **September 1, 2021 through September 30, 2021 Disbursement Register (Claim Docket)** in the amount of \$4,023,571.90 total disbursements. Included in this amount is student refunds in the amount of \$1,496,995.98. A motion was made by Sonny Knight, seconded by Brian Freeman, to approve the Disbursement Register as presented herein. The motion was unanimous. The original Disbursement Register is on file in the Business Office.

Ms. Clark presented for approval the **October 2021 Fixed Assets Deletion Report** for institutionwide in the amount of \$2,344,139.31. The report contains various unserviceable computers, electronic items, electrical equipment and appliances that are no longer in use and will be prepared for salvage. A motion was made by Sonny Knight, seconded by Dale Purvis, to approve the October 2021 Fixed Assets Deletion Report as stated and defined herein. The motion was unanimous. The original report is on file in the Business Office.
